The evening's presenters were long-time Chairman, Ron Provo, and Jennifer Watson, Chief Executive Officer (CEO).

Provo reported on the financials and the excellent exam report Limestone received from the National Credit Union Association (NCUA). Provo spoke proudly and paid respects to the Limestone team for their hard work and dedication during the past year, maintaining their stellar standing amongst the top credit unions in their asset size not only in the state but nationally.

Provo also took a moment to ask all of our veterans who were in attendance to stand so members could thank and honor them with a round of applause for their service to our country. Fittingly, the designated charity for the night was the Upper Peninsula's Honor Flight program.
